With reference to the said letter, please find below pointwise submission from the Company:

1. Following entity is covered as promoter/promoter group in System Driven Disclosures (SDD) for Insider Trading (as per SEBI circular dated September 09, 2020), however not appearing as promoter/promoter group as per Table II of shareholding pattern (SHP) or vice-versa:

*Name of the Promoter / Promoter Group were mentioned in the System Driven Disclosure (“SDD”) to track any transaction in the shares of the Company, to be taken by the specific promoter / promoter group. However, as on the date of reporting, the Promoter Group (as mentioned in the list shared by you), do not hold any shares in the Company. Therefore, in the shareholding pattern their name are not appearing.*

*Further, we would like to inform you that the Dreamz Dwellers LLP (“Dreamz”) is holding shares in the Company which is reported under the Shareholding Pattern filed with the Stock Exchange but the name of Dreamz Dwellers LLP inadvertently missed to report under the SDD. This happened as we were trying to file the data with Central Depository Systems Limited multiple time. While uploading it was giving error and insist to amend the list and while doing that process the name of Dreamz Dwellers LLP was missed inadvertently.*

2. Following entity is covered as promoter/promoter group in System Driven Disclosures (SDD) for Insider Trading (as per SEBI circular dated September 09, 2020), however not appearing as promoter/promoter group as per Table II of shareholding pattern (SHP) or vice-versa:
